SCHEDULE OF TUITION for July Institute

1. Regular Registration Fees

Unless Plan 2A or 2B apply, the Registration Fee for the CLE Seminars is \$250 each day for OMAA Members only. The fee for Nonmembers is \$350 each day.

Discount Plans

- 2A. If ten or more civil side and/or prosecutors from your municipality attend the same CLE seminars, the Registration Fee is \$150 each day, for OMAA members. The fee is \$250 each day, for nonmembers. All must attend the same seminar. The freedom to move between civil and criminal sessions is permitted.
- 2B. If your municipality's population is 60,000 or less and if five or more civil side and/or prosecutors from your municipality attend the same CLE seminar, the Registration Fee is \$150 each day attended, for OMAA members. The fee is \$250 each day, for nonmembers. All must attend the same seminar. The freedom to move between the civil and criminal sessions is permitted.
