

2020 OMAA/OML WEBINAR: SMALL CELL TOWERS UNDER ORC 4939 AND THE FCC ORDER

PROGRAM OVERVIEW:

On May 2, 2018, former Governor Kasich signed House Bill 478, legislation regulating the deployment of small cell wireless infrastructure in municipal rights-of-way, into law. According to the Ohio Municipal League, the signing of this bill “mark[ed] the achievement of both municipal leaders across the state and the telecommunications industry representatives who spent countless hours . . . to reach a compromise of both parties.” In 2019, an Order from the Federal Communications Commission (FCC) went into effect that further restricted the timeline, fees, aesthetics, and more. This webinar will overview the federal and state restrictions on requirements that municipalities may seek to impose on small cell infrastructure expansion in rights-of-way and opportunities to still be proactive in the construction of such facilities within your municipality.
